This includes parent communication, social media campaigns, information on public websites, newsletters, signage in the school setting.</p> <p>All health plans will be developed collaboratively with CPSD6 District Nurses and LPHA.</p>

**PRACTICING PLAN TO IMPROVE PROCESS**

Training exercises are essential to preparedness ensuring individuals understand their role in a communicable disease event. Exercises can also help identify gaps in the planning, thereby building upon and strengthening the plan over time. Schools, districts, and ESDs should schedule to exercise this plan annually and when any revisions are made to update the plan.
