Describe how you will devote time for students and staff to connect and build relationships.	<p>SVE has a strong commitment to Social Emotional Learning and supports. All of our students receive regular instruction in SEL through a curriculum called, “Purposeful People.” Our staff has been utilizing this curriculum for the previous 2 years and has been trained. Our SWS helps facilitate the skills learned in this program by supporting SEL school-wide with events, activities, small group coaching, and supports both in and out of the classroom.</p> <p>SVE also has a strong Positive Behavior Support Intervention (PBIS) Program. We have experienced support staff who have been highly trained in providing positive behavior supports. They use their skills to keep SVE a kind, engaging, supportive school by encouraging and coaching our students to Be Safe, Be Respectful and Be Responsible. We are committed to helping all students connect to the resources they need to be successful and to learn through coaching and practice. PBIS support is always available to our students.</p>

Our SWS will specifically be supporting students and teachers as their needs arise. This specialist will be working with classroom teachers to determine current student needs and develop lessons and activities to support those needs. This could mean forming friendship groups, grief groups, provide modeling, getting students connected to counselors, etc. The SWS will also help provide opportunities for our staff to stay mentally and physically healthy as well.

Our website has links to our suicide prevention plan, culture of care, and various community resources. We direct staff to our administrative assistant in Benefits for support as well as refer our parents, students, and staff to on-site counseling resources through LaClinica Mental Health Services. In addition, Student Wellness Specialists offer socio-emotional support to students. Higher levels of care will be referred by building and district administration to appropriate county resources.
Describe how you will foster peer/student lead initiatives on wellbeing and mental health.	<p>SVE will be promoting student nutrition through a partnership with the Oregon Dairy and Nutrition Council. We will be providing “Smoothie Mondays” as a way to help students get a good start to their learning week with good nutrition. We also received a “Fuel Up to Play 60” grant in which we will be supporting our students in playing and learning the game of flag football. Additionally, we have a partnership with Rogue Valley Farm to School which also helps support good nutrition and gets students working cooperatively in our school garden.</p> <p>School-wide, we will be supporting the “Purposeful People” curriculum with school character monthly themes. These themes include perseverance, empathy, respect, responsibility, honesty, gratitude, cooperation, creativity, and courage. These themes are a major focus of our school communication and the theme is always discussed each morning during our morning school announcements.</p>
